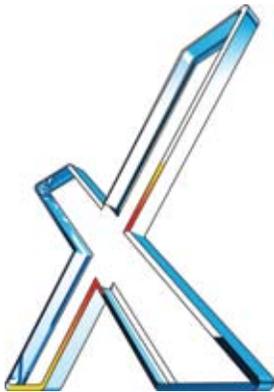

Cambridge is ranked as the No. 1 University in the World in the London Times QS ranking in 2010. The Cambridge Judge Business is ranked as one of the leading international business schools.

Since 1993, Dr. Abeln has held key leadership positions at major business schools with extensive experience in MBA, academic programs, curriculum development and executive education. He was formerly Director of the MBA Program at the Massachusetts Institute of Technology School of Management (MIT) Sloan School of Management and the Associate Dean of the Business School at Georgetown University in Washington D.C.

Dr. Abeln received a Ph.D. in Management and M.Phil. in International Relations from Cambridge University, where he was a Rotary Foundation Scholar. He received his undergraduate degree from The University of Pennsylvania where he graduated Phi Beta Kappa and Magna Cum Laude.

Dr. Abeln has also served on the Board of Directors of The Massachusetts Institute of Technology (MIT) Enterprise Forum. Dr. Abeln has also been the founder of three companies. He was a founding core team member of the Royal Dutch Shell Project Academy in and has worked with many global corporate clients across industries to develop and deliver management education. He currently is a member of the Board of Governors of the Kings School, Ely.

Dr. Abeln has written on the trends in graduate management education and been quoted in The New York Times, The Financial Times, The Wall Street Journal, The London Times, The Independent and many other publications. He has appeared on ABC, CBS and other television and radio affiliates. He is completing a book entitled 'The DNA of Business Schools' expected to be published in 2011.

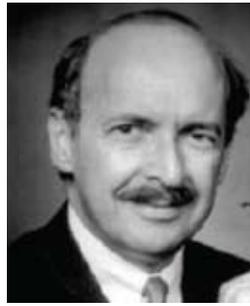

**William T. Allen**

William T. Allen holds the Jack Nusbaum Chair in Law & Business at New York University and serves as Director of the NYU Pollack Center for Law & Business, a joint undertaking of the Stern School of Business and the NYU School of Law. He is a member of the Law School faculty and the faculty of the Department of Finance of the Stern School. He teaches and writes in corporation law and governance, and mergers and acquisitions. At the law school he also serves as Director of the LL.M. Program in Corporate Law. Since 1997 Mr. Allen has been Of Counsel to the New York law firm Wachtell, Lipton, Rosen & Katz.

From 1985 to 1997 Mr. Allen was Chancellor (or chief judge) of the Court of Chancery of the State of Delaware. The Court of Chancery is noted as the leading court with primary jurisdiction for matters of corporate law and governance for corporations incorporated under the laws of the State of Delaware. As Chancellor, Mr. Allen wrote hundreds of judicial opinions treating issues of the fiduciary obligations of corporate directors. While serving as Chancellor, Mr. Allen taught corporation law and corporate governance as a Visiting Professor at Stanford Law School (1990 & 1994) and the University of Pennsylvania Law School (1992-93 & 1995). In 1996 he served as Rabin Lecturer at Yale Law School.

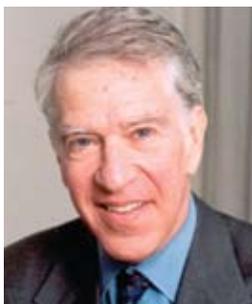
From 1997 to 2001 Mr. Allen served as founding Chair of the Independence Standards Board, a private sector organization designated in 1997 by the Securities & Exchange Commission with the task of promulgating standards for the determination of auditor independence. He has also served on the Legal Affairs Committee of the New York Stock Exchange and on the Board of Trustees of the University of Delaware (Executive, Nominations and Academic Affairs Committees). Mr. Allen is an elected member of the American Academy of Arts & Sciences and of the American Law Institute (Special Committee on Corporate Governance) among other professional associations.

Mr. Allen earned a B.S. degree from New York University, a J.D. from the University of Texas School of Law and was awarded an LL.D. honorary degree from Dickinson Law School of Pennsylvania State University. His published writings in corporation law and governance are numerous. He is author (with Reinier Kraakman and Guhan Subramanian) of COMMENTARY AND CASES ON LAW OF BUSINESS ORGANIZATION (Aspen Press 2nd 2007).

**Roger C. Altman**

Roger Altman is Founder and Chairman of Evercore Partners, which has become the most active investment banking boutique in the world.

Mr. Altman began his investment banking career at Lehman Brothers and became a general partner of that firm in 1974. Beginning in 1977, he served as Assistant Secretary of the U.S. Treasury for four years. He then returned to Lehman Brothers, later becoming co-head of overall investment banking, a member of the Firm's Management Committee and its Board. He remained in those positions until the firm was sold to Shearson/American Express.

In 1987, Mr. Altman joined The Blackstone Group as Vice Chairman, head of the Firm's merger and acquisition advisory business and a member of its Investment Committee. Mr. Altman also had primary responsibility for Blackstone's international business.

Beginning in January 1993, Mr. Altman returned to Washington to serve as Deputy Secretary of the U.S. Treasury for two years. In 1996, he formed Evercore Partners. To date, the Firm has handled over \$1 trillion of merger, acquisition, recapitalization and restructuring transactions. In its other role, Evercore also manages approximately \$15 billion of third party assets.

Mr. Altman is a Trustee of New York-Presbyterian Hospital, serving on its Investment Committee, and is Vice Chairman of The Board of The American Museum of Natural History. He also serves as Chairman of New Visions for Public Schools. He is a member of The Council on Foreign Relations and a Director of Conservation International. He received an A.B. from Georgetown University and an M.B.A. from the University of Chicago.

William R. Berkley founded W. R. Berkley Corporation, a Fortune 500 property-casualty insurance holding company with assets of over \$16 billion and annual revenues of \$5 billion, in 1967 and has served continuously as Chairman of the Board and the Company's Chief Executive Officer. In addition, he is Chairman of many of the Company subsidiaries, including Berkley Dean & Company, an investment management company.

During his career, Mr. Berkley has founded a number of public and private companies, some of which he continues to control. He serves as Chairman, Lead Director or Director on many of these enterprises, including The First Marblehead Corporation, the leading private student loan company in the United States. In addition to these enterprises he has similar roles in several financial institutions, including two banks and a number of industrial companies. He is Chairman of the American Insurance Association, and is a member of the Board of Directors of the National Parks Conservation Association.

Mr. Berkley is a graduate of New York University and the Harvard Graduate School of Business Administration. He is Chairman of the Board of Overseers of the Stern School of Business at New York University, as well as Vice Chairman of the Board of Trustees at New York University, where he serves on the Executive and Finance Committees. He is a Director of Georgetown University, where he helped organize and form the Berkley Center for Religion, Peace, and World Affairs, which is devoted to fostering inter-religious dialogue with a goal of improving global cultural understanding. He is actively involved at both Georgetown University and New York University in this as well as many other projects.

Mr. Berkley is Chairman of Achievement First, a group of charter schools operating in the New York Metropolitan area, serving over 4000 inner-city children in Connecticut and New York. Achievement First schools have been rated amongst the outstanding charter schools in America.

Mr. Berkley has received many awards for his business, civic and philanthropic activities, including an honorary doctor of law degree from Mercy College. In 1999, he was awarded the Medallion for Entrepreneurship by Beta Gamma Sigma, which honors outstanding individuals who combine innovative business achievements with service to humanity. In April 2006 he received the Charles Waldo Haskins award, given annually by NYU's Stern School of Business to a nationally prominent business and public service leader.

Mr. Cebrián was a founding member of the political magazine Cuadernos para el diálogo since 1963, and from 1963 to 1975 he served as the Chief Editor and Assistant Editor in Chief of the Madrid newspapers Pueblo and Informaciones. Mr. Cebrián served as the News Editor in Chief of the public Spanish TV network (TVE). Mr. Cebrián was the founding Editor in Chief of the daily EL PAÍS, and kept this post from 1976 to November 1988. From 1986 to 1988 he served as the Chairman of the International Press Institute (IPI). He served as the Chief Executive Officer of Grupo PRISA and EL PAÍS since November, 1988. He serves as Vice Chairman of Sogecable SA. and is a Non Executive Director of Media Capital S.G.P.S since November 15, 2005. Among the numerous journalism awards to his credit are: New York's World Press Review's Editor of the Year Award in 1980; the Premio Nacional de Periodismo (National Journalism Award) in 1983; the Free Speech Medal from the F.D. Roosevelt Four Freedom Foundation and the Medal of Honor from the University of Missouri in 1986; and the Premio Internacional Trento de Periodismo y Comunicación (Trento International Award for Journalism and Communication, in 1987. Knight of the Order of Arts and Letters in France, he was named Honorary Professor by the Universidad Iberoamericana de Santo Domingo (Dominican Republic), and he is a member of the Spanish Royal Academy since 1997. In 2003, he was honored by La Plata University (Argentina) and he was awarded the Medal for Merit Universidad Veracruzana (Mexico) and he received the Honor Medal of the University of Santiago de Chile. He has led an intense professional life as a columnist and lecturer. He is the author of many books, among which include: La prensa y la calle (Nuestra Cultura), The Press and Main Street (Michigan University Press), La España que bosteza (Taurus), El tamaño del elefante (Alianza Editorial), La Isla del Viento (Alfaguara), El siglo de las sombras (El País Aguilar), Cartas a un joven periodista (Ariel Planeta), and La Red (Taurus). In February 2000, he published La agonía del dragón (Alfaguara). El futuro no es lo que era (Taurus) was released in September 2001, which is a long conversation between Spain's former Prime Minister Felipe González and Mr. Cebrián and constitutes a debate on the content of politics and the future of digital society. In 2003, he published Francomoribundia the second part of the trilogy El miedo y la fuerza, which the first part was La agonía del dragón. The American edition of this essay on journalism, "The pianist in the brothel" will appear next November in New York (Overlook Press) He studied Philosophy at the Universidad Complutense (Madrid) and received a BS from Escuela Oficial de Periodismo in Madrid, ( Spain).

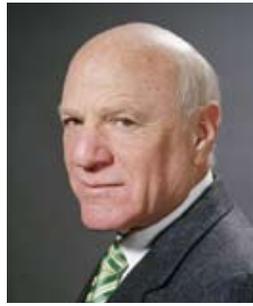

Mr. Diller was born in San Francisco and raised in Beverly Hills. He serves on the boards of The Washington Post Company and The Coca-Cola Company. **Peter Blair Henry**

Dean  
NYU Stern School of Business

Peter Blair Henry was named Dean of New York University's Leonard N. Stern School of Business on July 28, 2009 and assumed the deanship on January 15, 2010. He joined NYU Stern from Stanford University where he was the Konosuke Matsushita Professor of International Economics, the John and Cynthia Fry Gunn Faculty Scholar, and Associate Director of the Center for Global Business and the Economy at the Stanford University Graduate School of Business. Prior to assuming his current position, Dean Henry was also a Senior Fellow of the Stanford Institute for Economic Policy Research.

Dean Henry is a Research Associate at the National Bureau of Economic Research, a Nonresident Senior Fellow of the Brookings Institution, and a member of the Council on Foreign Relations. From 2000-2001 he was a National Fellow at the Hoover Institution. The National Science Foundation's Early CAREER Development Program supported his research and teaching from 2001-2006. In 2004 Dean Henry participated in the Copenhagen Consensus, an international conference on how to make the most efficient use of the world's scarcest resources. The Economist magazine named the published proceedings of the conference one of the best business books of 2004.

The author of numerous articles and book chapters, Dean Henry is best known for a series of publications in the three flagship journals of the American Economic Association that overturn conventional wisdom on the topics of debt relief, international capital flows, and the role of institutions in economic growth: "Debt Relief" Journal of Economic Perspectives (Winter 2006); "Capital Account Liberalization: Theory, Evidence, and Speculation" Journal of Economic Literature (December 2007); "Institutions vs. Policies: A Tale of Two Islands" American Economic Review (May 2009). He is currently writing a book for Oxford University Press. Dean Henry received his PhD in economics from the Massachusetts Institute of Technology in 1997. While in graduate school, he served as a consultant to the Governors of the Bank of Jamaica and the Eastern Caribbean Central Bank (ECCB). His research at the ECCB contributed to the intellectual foundation for establishing the first stock market in the Eastern Caribbean Currency Area.

Prior to attending MIT, Dean Henry was a Rhodes Scholar at Oxford University where he received a BA in mathematics and a Full Blue in basketball. He also holds a BA in economics from The University of North Carolina at Chapel Hill where he was a Morehead Scholar, a National Merit Scholar, a member of Phi Beta Kappa, and a Marshall Scholar-Elect.

Born in Jamaica, Dean Henry became a U.S. citizen in 1986.

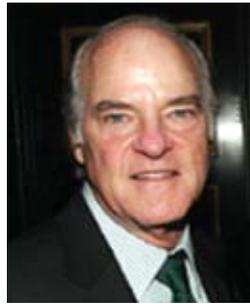

He is actively involved in managing the firm and serves on the Investment and Portfolio Management Committees.

Prior to co-founding KKR, Henry Kravis was in the Corporate Finance Department of Bear Stearns & Company from 1969 to 1976. During this time, he, along with George Roberts and Jerome Kohlberg, pioneered the use of leverage in acquisitions.

Henry Kravis earned a B.A. in Economics from Claremont McKenna College and an M.B.A. from the Columbia University Graduate School of Business. Over the years, he has been a member of the board of directors of numerous public and private companies. He currently serves on the board of First Data Corporation. He also currently serves as a director or trustee of several cultural and educational institutions, including the Partnership for New York City, Mount Sinai Hospital, WNET.ORG (New York public television stations Thirteen - WNET and WLIW21), Columbia Graduate School of Business (where he is chairman of the board), Rockefeller University, and Claremont McKenna College.

Mr. Kravis is co-chairman of the New York City Investment Fund (NYCIF), a non-profit organization he founded in 1996 to create jobs and help small businesses in New York City. In response to other targeted needs that have arisen in the city, the Fund has created special purpose programs. For example, the NYCIF was responsible for raising \$11 million to provide 88 recoverable grants to small businesses in Lower Manhattan that suffered damage following the events of September 11, 2001.

At Claremont McKenna College, he founded the Kravis Leadership Institute and established the Kravis Prize in Leadership, which is awarded annually to an international, non-profit organization that demonstrates leadership, creativity, and sustainability. Henry Kravis also serves on the board of the Council on Foreign Relations.

In 1992 Mr. Lipton served on the Subcouncil on Corporate Governance and Financial Markets of the United States Competiveness Policy Council, which resulted in his co-authoring with his fellow member of the Subcouncil, Prof. Jay Lorsch of The Harvard Business School, an article, *A Modest Proposal for Improved Corporate Governance*, which became the template for much of the basic corporate governance principles that were adopted in the 1990's. Mr. Lipton served as counsel to the New York Stock Exchange Committee on Market Structure, Governance and Ownership (1999-2000), as counsel to, and member of, its Committee on Corporate Accountability and Listing Standards [Corporate Governance] (2002) and as Chairman of its Legal Advisory Committee (2002-2004). Mr. Lipton is a Member of the Executive Committee of the Partnership for New York City and served as its Co-Chair (2004-2006). Mr. Lipton has a B.S. in Economics from the Wharton School of the University of Pennsylvania and an L.L.B. from the New York University School of Law. 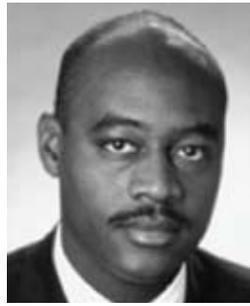

Richard L. Revesz is one of the nation's leading voices in the fields of environmental and regulatory law and policy. He has published numerous books and more than 50 articles in major law reviews and journals on these subjects. His work specifically focuses on the use of cost-benefit analysis in administrative regulation, federalism and environmental regulation, design of liability regimes for environmental protection, positive political economy analysis of environmental regulation, and analytical foundations of environmental law. In 1994 and 2007, he received the American Bar Association's award for the best article or book on administrative law and regulatory practice published the previous year.

In his most recent book, *Retaking Rationality: How Cost-Benefit Analysis Can Better Protect the Environment and Our Health* (Oxford University Press, 2008), Dean Revesz and co-author Michael Livermore argue that a key cause of our failure to do a better job protecting the environment has been a "rejection of reason" by environmentalists and other progressive groups. *Retaking Rationality* contends that the economic analysis of the law is not exclusively an analytic method supporting conservative results, but can support a more protective approach to environmental and public health policy.

Throughout his career, Dean Revesz has actively participated in shaping environmental regulation and public policy. He was recently appointed to the National Research Council's Committee on Health, Environmental, and Other External Costs and Benefits of Energy Production and Consumption to study the costs and benefits of U.S. energy production and use for parties not directly involved in energy decisions. Funded by the U.S. Treasury Department, the committee will deliver a report to the new president and Congress in the summer of 2009 to better inform national energy policy. He previously was a member of the Environmental Economics Advisory Committee of the U.S. Environmental Protection Agency's Science Advisory Board and has testified before Congress on the reauthorization of the Clean Air Act and on reforms to the Superfund program, which imposes liability for the disposal of hazardous waste. Dean Revesz also was a consultant to the Carnegie Commission on Science, Technology, and Government, the United Nations Department of Technical Cooperation for Development, and the Administrative Conference of the United States, and chaired the Committee on Judicial Review of the American Bar Association's Section on Administrative Law and Regulatory Policy.

Professor Weiyang Zhang is Dean of the Guanghua School of Management of Peking University, Professor of economics, and Director of the e-Business Center of Peking University. Professor Weiyang Zhang graduated with a Bachelor's degree in 1982, and a Master's degree in 1984, from Northwestern University at Xi'an. He received his M. Phil. in economics in 1992 and D. Phil. in economics from Oxford University 1994. From 1984 to 1990, he was a research fellow of the Economic System Reform Institute of China under the State Commission of Restructuring Economic System. During this period, he was heavily involved in economic reform policy making in China and was the first Chinese economist who proposed the "dual-track price system reform" (in 1984). After he graduated from Oxford, he co-founded Peking University's China Center for Economic Research in 1994, and worked with the Center until August 1997. He then moved to Guanghua School of Management in September 1997. He was appointed as associate dean in February 1999 and Dean in September 2006.

Professor Weiyang Zhang has played a leading role in transforming Guanghua School of Management since 1999. His visionary reform measures have generated significant impacts on changes of business education in China. He was the chief architect of the 2003 Peking University faculty system reform. Professor Weiyang Zhang's research interests include the industrial organization, corporate governance, information economics, and Chinese economic reform. He is a widely recognized authority of the theory of the firm and ownership reform in China. As the author of dozens of journal papers and 10 books, he has been the most cited economist in Chinese academic journals since 1995. His works have had significant impacts on the ongoing enterprise reform policy formulation and the development of economics in China. He was awarded the "National Science Fund for Distinguished Young Scholars" in 2000 by the Natural Science Foundation of China, and "the Man of the Year in Chinese Economy" by CCTV in 2002.

Professor Weiyang Zhang has extensive consulting experiences with both governmental departments and business enterprises. He was once a member of the Advisory Board on Enterprise Reform to the State Commission for Restructuring Economic system between, a consultant to the Department of Enterprises of the State Economic and Trade Commission, and a local consultant to the World Bank Project on Chinese Stateowned Enterprises Reform. Currently he is a member of the Advisory Board for the State Informatization Committee, and a member of the Advisory Board for Telecommunication Law Drafting Committee.
